UAC Function

CASIS has provided an update to the UAC mission which has been approved in March 2024

The ISS National Lab UAC shall be an advisory body to the CASIS Chief Executive Officer (CEO)

The UAC shall:

- Review and provide inputs on prioritization and selection processes.
- Serve as an advocacy group for the ISS National Lab and its user community.
- Provide insight into the research goals of the user community.
- Provide recommendations for resolution of user community issues as well as improvements to the user experience.
- Respond to task assignments by the ISS National Lab to identify and assess enhancements that will increase functionality and utility for the user community.



UAC Function

Goals - What long-term targets do we want to achieve?

From the UAC Charter:

- Provide an organized framework and forum for interaction between the parties interested in [working with CASIS]
- Facilitate the availability and effective use of ISS National Lab for the research community
